



IMPORTANT INFORMATION REGARDING 2022 HEALTHFIRST/ADVENT HEALTH MEDICARE ADVANTAGE PLAN!

Dear Retiree,

We have recently learned that HealthFirst/Advent Health will no longer be offering Group Medicare plans effective 1/1/2022, and our records show that you are currently enrolled in the HealthFirst/Advent Health Medicare Medical Plan - which means that your current Medicare plan will no longer be available in 2022. In order to assist you with this change, **FSRBC will automatically enroll you in a similar Medicare Advantage Plan to ensure you have coverage in 2022.** You will be able to retain, change, or waive this plan during Annual Enrollment – more details below.

Based on this recent news there are several changes that will impact you:

- You will automatically be moved into a similar Medicare Advantage Plan through UnitedHealthcare, shown below. **Please visit our website <https://myfsrbc.com/> for plan details and 2022 monthly costs.**

- During Annual Enrollment, beginning October 15, 2021, you will have the opportunity to change plans or waive coverage entirely. **If you do not take action during Annual Enrollment, you will remain in the UnitedHealthcare plan for 2022.**
- Premium payment methods will remain the same in 2022, but premium amounts may go up. For example, if you are currently paying through FRS/Pension, this will continue in 2022, but you will be charged the cost of the UnitedHealthcare plan.
- Providers in Medicare will be in-network with UnitedHealthcare.

As we continue to work with HealthFirst/Advent Health and UnitedHealthcare on this transition for 2022, we will post updates to our website <https://myfsrbc.com/>. Please check periodically for additional information.
